

POST YEAR-END EVENTS

Order by Greece of 18 Rafale (6 new and 12 pre-owned)

- Signature and coming into force of the contract in January 2021
- 1st European Rafale Export country and 4th Rafale Export customer
- 1st used aircraft deliveries from 2021

This brings the total number of Rafale Export ordered up to 102.

France announced an order of 12 additional Rafale.

2020 CONTEXT

- Covid-19:
 - unprecedented worldwide sanitary crisis
 - strong impacts on global economy
 - severe travel restrictions
 - aviation sector strongly affected
 - French aviation support plan
- International tensions due to some country's policy of power affirmation
- Terrorism
- Rise of environmental concerns

→ 2021: strong sanitary, economical and geopolitical uncertainties



FRENCH AVIATION SUPPORT PLAN

In addition to temporary furlough, the French government support plan for the aviation industry launched on June 9, 2020 is being implemented:

- Government secured loans and flexible temporary furlough plan enabled to avoid major bankrupcies in 2020
- Investment fund implemented by Airbus, Dassault Aviation, Thales and Safran and co-funded by French government, to back and consolidate SMEs and intermediate-sized enterprises in the sector
- CORAC package: EUR 1.5 billion over 3 years

avoid supply chain collapse

In 2020, Dassault Aviation:

- Received € 6 M of state temporary furlough allowance
- Paid € 1 M to the investment fund out of the € 13 M commitment
- Received € 8 M from CORAC



DASSAULT AVIATION FACING COVID-19

A robust health protocol allowed a quick resumption of activities following a total shutdown of the Company in March 2020 (resort to temporary furlough).

Responsive and agile, we focused on meeting our commitments:

- support for the Armed Forces and Falcon customers
- delivery of the Rafale Export and Falcon
- continuation of the development of the Falcon 6X

Ongoing Rafale Export prospecting abroad.

The level of Falcon order intake was strongly affected by the crisis.

Some delays were generated (workplace closures, subcontractor delays, etc.).

In these exceptional circumstances, our shareholders have supported us by waiving their 2020 dividends.







RAFALE EXPORT

- 13 Rafale deliveries to India and Qatar, as per our commitments
- entry into service of the Rafale in India
- ongoing prospection abroad, despite the Covid-19 constraints







RAFALE FRANCE

- Continuation of Standard F4 development works
- No French Rafale delivery in 2020 and 2021 in accordance with France's Military Procurement Law ("LPM")
- Deliveries of Rafale to France due to resume in 2022; 40 Rafale still to be delivered out of 180 ordered + 12 announced
- 5th batch:
 - start of preliminary works
 - deliveries scheduled by the LPM from 2027 (order expected in 2023)



- continuing to provide support for the Egyptian and Qatari Rafale






MILITARY SUPPORT (2/2)

ATLANTIQUE 2

Signature of the OCEAN support contract for the French Navy's ATL2:

- Dassault Aviation: sole contractor, excluding engines, for the 10-year integrated support contract (including Thales)
- organization of this support based on a Dassault Aviation/Dassault Systèmes Big Data platform, same as the one used on the RAVEL contract

Delivery to the French Navy early April 2020 of the 3rd upgraded ATL2 out of the 7 to be performed by Dassault Aviation





MULTI-MISSION FALCON

France

- Albatros: contract for the maritime surveillance aircraft program based on a Falcon 2000LXS platform (7 ordered, 5 in option)
- Archange: launch of the strategic intelligence aircraft program based on a Falcon 8X platform (2 ordered in 2019, 1 in option)
- Falcon 50M: delivery of the 3rd and 4th aircraft, equipped with hatches for dropping SAR (Search And Rescue) kits

Japan

 Japan Coast Guard: delivery of the 5th Maritime Surveillance Falcon 2000 out of 6 ordered

FUTURE COMBAT AIR SYSTEM (FCAS)

- February 2020: following the launch of the JCS (Joint Concept Studies), launch of phase 1A of the FCAS demonstrators, and in particular the New Generation Fighter
- December 2020: integration of Spain in the initial contract and new equilibrium
- 2021: preparation of phases 1B and 2 for the demonstrators. Proposals have been submitted. Equilibrium between the 3 states is tough: Dassault Aviation leader of the NGF, but the "3 thirds" rule to share workload and responsibilities (equal partners / quality balanced) leads Germany / Spain and Airbus to a disagreement with France and Dassault Aviation
- Difficulties pending on contractualisation: project management and intellectual property





EURODRONE

- Contract between the Organization for Joint Armament Cooperation (OCCAR) and Airbus Defence & Space GmbH (prime contractor) has been negociated
- Contracts between Airbus Defence & Space and its main partners, Leonardo and Dassault Aviation are being finalized
- Dassault Aviation will be responsible in particular for flight controls and mission communications
- Notification expected mid-2021





FALCON MARKET CONTEXT

Delivery of 34 Falcon, for an initial forecast of 40, revised to 30 due to Covid-19 crisis.

Travel restrictions and the severe economic consequences due to the Covid-19 pandemic affect the business jet market:

- 15 orders including 7 Albatros aircraft due to customers' lack of visibility
- continuing price pressure
- under-used capacity of our maintenance centers due to the decline in aviation activity





FALCON 6X

1st flight early 2021 Entry into service expected late 2022

- eRoll-out of the Falcon 6X on December 8, 2020
- new standard for the long-range, ultra-widebody business jet segment
- first 3 development aircraft on test, and assembly on serial aircraft #4 and #5 started
- PW812D engine: successful ground and flight tests validating the aircraft's flight capability
- Falcon 6X cabin awarded by the International Yacht and Aviation Award for Interior Design











IN € BILLION









CONSOLIDATED AVAILABLE CASH

The € 3.4 Bn cash includes in particular, Rafale Export down payments received for ongoing contracts.

The decrease is primarily due to the Rafale Export contract execution (increase in working capital requirement resulting from the decrease in advances and progress payments received for Export contracts following deliveries), and to the significant investments made during the period.

The application of Group specific agreements will lead to a payment of € 85 M in profit-sharing and incentives schemes (including the specific correlated social tax) vs € 187 M on 2019 earnings.

On 2020 earnings, the application of the legal formula would have led to a payment of € 2 M in profit-sharing and incentives schemes.



SPLIT OF THE PAR VALUE OF THE SHARE

Proposal to split, by 10, the par value of the Dassault Aviation share in order to:

- align the share value with peers of the industry,
- allow a better accessibility to individual investors and to investment funds dedicated to individuals,
- help stock liquidity,
- answer positively to a frequent request from individual shareholders in General Meetings.

This proposal will be submitted for the approval of the Annual General Meeting of May 11, 2021. The par value of the share would, then, be cut from 8 euros per share to 0.80 euro per share. The split would occur during second half of 2021.



OUTLOOK AND STRATEGY

In 2020, this crisis demonstrated the relevance of our dual model as well as our resilience. For 2021:

- Export Rafale: perform contracts and continue to explore new business opportunities
- Falcon: increase sales
- Falcon 6X: continue development aiming at its entry into service in late 2022
- Military developments: pursue the current programs (F4 standard, Archange, Albatros, etc.)
- Preparation of the future: keep to the schedule for the future Falcon
- New Generation Fighter: obtain the launch of phases 1B and 2
- Eurodrone: secure a contract
- 5th batch of Rafale France: prepare to obtain the productability contract
- Aircraft support and availability: maintain the highest standards
- Energy transition: secure CORAC orders
- Make in India: continue developing the activities transferred to DRAL

Guidance 2021:

- Delivery of 25 Rafale and 25 Falcon
- Increase of net sales
